## SKI BUSHING KIT INSTRUCTIONS

Remove left and right ski. Using punch or suitable bushing remover, remove both inner and outer stock ski leg bushing from both ski legs. Clean and inspect ski leg for wear, and tolerance specification.

With ski leg cleaned and inspected, install new composite bushings using a pistol grip clamp. Install one bushing at a time. Press until flush with the side of the ski leg, being careful not to damage the outer flange on the bushing.

Install anodized ski leg sleeve, placing spacers on either side of sleeve. By placing spacers on either side, you will ensure a much longer service life for your new composite bushings.

Re-install skis. Torque to 35 ft. pounds
